Niemeyer – In advertising for the replacement of Nick Doffin, was there a clear job description? Also, was there a process that you underwent to advertise, interview and vet candidates?

Cid – She went through human resources.

Niemeyer – As I look at these sorts of positions, I just want to make sure that if we're hiring someone, we have clarity of job descriptions and a good, robust process of vetting candidates because this is a pretty substantial increase after the budget has already been adopted. I was looking through some other health departments, and it does seem that the \$110,000, while it's in line with some, the state-wide average is still below \$94,387. I would love to see this be a range of salary rather than us having to pay someone \$110,000.

Brewer – My concern still remains with the increase of salary. With the advertisement and with the individuals that came to apply for it, what would you say the range or number is that people have said the salary is too low for them to take this position?

Dr. Vavilala – There wasn't much discussion about the salary. None of the members specifically asked for this salary. However, this is based on the Indiana Local Health Department Assessment, which was done by the Richard Fairfax School of Medicine in 2022, comparing the local health departments across the State of Indiana, which basically showed that local health departments, especially Lake County, are one of the lower paid salaries. Hence the reason why we believe that this particular salary of \$110,000 is a reasonable ask for a job of this much responsibility: overseeing the second largest county in the state of Indiana. There is a lot more additional responsibility even when compared to when Nick started, as well as an additional grant that is millions of dollars, which requires someone who is dedicated and also someone who is going to be hardworking to achieve what we want and want to see, as well as the health department being run responsibly.

Brewer – My concern is if we go with \$110,000, we kind of max it out to where there is no room to grow for increases. Let's get a person in and see how they do. If we're looking at a range, we can always entertain a raise next year during budget time if we see that they are producing the way we think they should. The big increase right off the bat is a concern for me.

Dr. Vavilala – With the salary Nick is being paid, we might be able to find a candidate that will do a decent job. However, for a county of this size, there is a lot of responsibility that goes with this administrator job. If we are going to underpay, then we'll get two kinds of candidates: one is probably not as qualified, and the other is we might find people that are qualified for the job, and they'll take the salary, but they would immediately be looking for a job somewhere else that they would be paid extra. If we are going to compensate someone, I think this is reasonable compensation. As I have said, we may be comparing with some other counties, but if we are comparing with a county of similar size, like Allen County, the administrator is being paid \$120,000 per year, and that county is smaller than Lake County.

Cid – It's not an unreasonable ask in my opinion; however, I think if you have someone in mind, is this the salary that they are willing to accept?

Vavilala – Yes.

Bilski – Although we may not be equal to some of the other counties, we have an outstanding benefit package. I hope it's told to the applicant that even though we may be \$10,000 less than what they're looking for, we have attractive benefits like vacation and holiday.

Niemeyer – Was the replacement for Nick already chosen prior to the interview process, or did we do the interview process first? And how many candidates did you interview?

Vavilala – We interviewed three people who have applied for the job. We have not offered the job to anyone. I did not want to offer, not knowing what to expect.

Brewer – It hasn't been offered, but there's an individual who is going to take the \$110,000. How do you know the individual is going to take the \$110,000 if it has not been offered to someone?

Vavilala – During the interview process, if we feel that the candidate is viable, we ask them what is the salary that they're looking at. That doesn't mean that we are offering them the salary.

Cid – I reached out to the corrections union and they said they were fine with the thirty days but it's the bond they still have concerns about. They have concerns on if it would be returned.

O'Donnell – The purpose of the bond is to try to cover the cost of the transcript so it wouldn't be return. Maybe there still needs to be some discussion on this.

Hamm made the motion, seconded by Bilski, to defer to February 11, 2025. Majority voted yes. Motion to defer to February 11, 2025 carried 7-0.

In the Matter of Acknowledgements – RDA Update

Randy Palmateer presented:

- Construction of the \$852 million West Lake Corridor from Hammond to Dyer is 84% complete.
- Construction of \$643 million Double Track is substantially complete, and revenue service began in May 2024.
- Transit Development Districts have been established in all eligible communities in Lake County. These should begin generating increment for RDA to use to fund development in 2025.
- RDA has hired a Controller and a Director of Economic Development to manage the finances of and development in the TDDs.
- Blight elimination work around the Gary Metro Station will begin in 2025, funded by the City of Gary and the State of Indiana via the RDA.
- The State also stand ready to provide \$100 million via the RDA as matching funds to build a Lake County Convention Center.
- RDA has updated its Comprehensive Strategic Plan. This update will be available shortly and RDA would like to thank all the Lake County stakeholders who participated in this process.

Update on the Rail Investment (11/24)

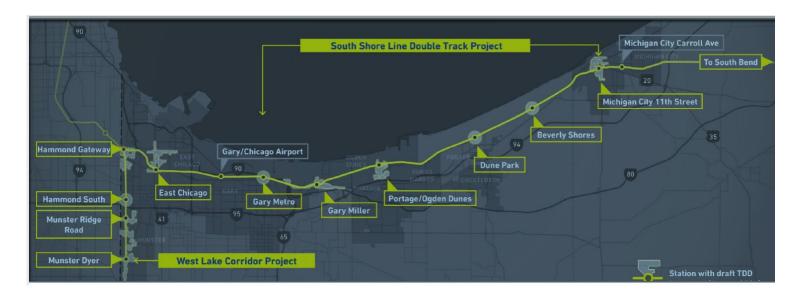
Development of the new rail lines and stations is progressing at a steady pace.

West Lake Corridor

- Design is 95% complete; train signals and operating systems remain in progress. Design of the last bridge (BR101) is complete as approval from the CSX railroad was received.
- With the exception of BR101 and the Main Street underpass at Munster Dyer station civil works are mostly done.
- Trackwork along the full length of the project is largely complete. Work is focused on installing poles for the catenary system and system (e.g. communications and power) installation.
- Paving is scheduled to begin for the west parking lot at Munster/Dyer stations, while work on the station and preparations for installation of the bridge over Main Street continue.
- Construction is 84% complete.
- An extended period of testing and commissioning is required between construction completion and Revenue Service.
- The NICTD team is focused on when the trains will be running. Revenue Service Date of May 1, 2025, is NICTD's current target. The FTA grant commitment is May 20, 2026.

Double Track

- 25-mile project area includes 16 miles of new second track, the closing of 20 grade-level crossings in Michigan City, and the elimination of "street running" in Michigan City.
- DT1 (Main rail project): Contract is substantially complete and very small number of punch list items remain.
- DT2 (MC 11th Street Station): Completion of the garage is scheduled for February 2025.
- Gary Miller Station (DT3), Portage/Ogden Dunes Parking Lot (DT4), Dune Park East Parking Lot (DT5) are complete.
- Positive Train Control (DT6) is complete.
- Overall, construction is 95% complete, 5% is attributable to the parking garage in Michigan City
- Revenue Service began on May 14, 2024, earlier than the FTA grant commitment of November 6, 2024.



- TDDs incentivize and promote development around South Shore stations.
- TDDs begin as a ½ square mile, or 320-acre, area around a station, and may be expanded once up to one square mile or 640 acres. They capture incremental property and income tax revenues, similar to a TIF district.
- All 7 TDDs in Lake County have been approved: Munster/Dyer Main Street, Munster Ridge Road, Hammond South, Hammond Gateway/Downtown, East Chicago, Gary Metro and Gary Miller.

Gary Blight Elimination and Metro Station Programs

- The State of Indiana has offered up to \$6 million in matching funds for blight elimination in downtown Gary around the Metro Station and within the Metro Station TDD.
- RDA would match up to \$3 million from Gary in 2024 and 2025, for a total of \$12 million in blight elimination funds. The state will reimburse the RDA in 2026.
- Gary secured a \$3 million commitment from the Hard Rock Casino to gain the 2024 RDA match. RDA is currently awaiting approval from the State AG's office on our Owner's Rep contract with Egis BLN, after which we and Gary will begin work ASAP.
- The same legislation also provides up to \$75 million in state matching funds for the construction of a new Gary Metro multi-modal station, also subject to matching funds from Gary.

Lake County Convention Center

- At the request of the legislature, RDA updated its 2018 feasibility study regarding a Lake County Convention Center in 2024. The update confirmed that such a facility was still viable post-COVID.
- Proposals for a convention center have been submitted by Gary and Hobart.
- The State is offering to provide up to \$100 million in matching funds over 20 years for construction of the facility. Those funds would be passed through the RDA, which would act as the state's fiscal agent on the project.

RDA Strategic Plan Update

- RDA issued a Request for Qualifications (RFQ) for firms to develop a comprehensive strategic development plan in November 2023.
- The RDA's mission to build the Region's major multi-jurisdictional infrastructure assets continues. However, the specific projects, the timing of those investments, and the possible returns to the regional economy have yet to be determined. The RDA sought a team of firms with several different skills sets, in combination and under the RDA's leadership, to construct a Comprehensive Strategic Development Plan to guide its mission and investments during the next two decades.
- Three firms were selected in Q1 2024: WSP, Avenew and JQOL
- Update is being finalized now.

Public Comments:

Barbara Koteles of Hobart – Dr. Vavilala mentioned a study, and as we all know, studies are funded by people who want a certain outcome. When I looked on the State of Indiana website for the average salary for an administrator, it was lower than that by twenty thousand dollars at least. This need to pay someone top dollar doesn't always work. In a recent health board meeting, they said that they hired someone for a position at top dollar. Something they could almost not afford, and that person quit before the end of the day because they had a better offer. I feel like, especially in the health industry, we expect people who are dealing with sick or unhealthy people to be empathetic. Is the desire to make money more powerful than the desire to be empathetic and do a good job? The correlation of the salary to the size of the county, that's not anything that's written in stone. I think it should be what we can afford. Most jobs that pay this kind of money do have a range of salary.

There being no further business to come before the Council, it was moved and seconded that this Council does now adjourn, to meet again as required by law.
